

## TMSH SHORT SELLERS



Starting in late 2010 short sellers have aggressively shorted TMSH. Shorts have continued this activity which warrants close investigation. Buyins.net will report the results of its surveillance on a monthly basis.


### OVERVIEW OF TMSH SHORT SALE DATA

After careful analysis of TMSH short sale, naked short sale and market maker friction factor data it is clear that TMSH has had persistent issues with short sellers who have been aggressive over the last several months. Short sellers have been

building a sizable position in shares of TMSH and market makers have made a slightly bullish market lately. New evidence of daily short sellers shorting shares of TMSH has now come to light as the SEC has finally


given Buyins.net access to DAILY short sale data which is updated every night. Protecting TMSH from abusive shorting is a high priority.

### PERCENT OF MONTHLY TRADING VOLUME SHORT IN TMSH



We track the percent of each month's total trading volume that was shorted. Buyins.net will continue to monitor and report short sellers for non-compliance with Regulation SHO borrow requirements.

### **NEW DAILY SHORT SALE TRADING VOLUME STARTING 11-3-09**



Shorts have been aggressively shorting TMSH on a daily basis. An average of 29.08% of daily trading volume is short selling.

The above data is used to calculate if a fair market is being made in the shares of TMSH. 53% of recent trading days are positive or bullishly biased and 47% of trading days are negative or bearishly biased. There is a slightly bullish market being made in TMSH in the past 38 trading days.

Friction Factor determines if there is normal or abnormal behavior in the price action of the stock when compared to the buying vs. selling trading statistics. It calculates number of net shares of buying or selling to move price +/- one cent.

### Here is how to understand Friction Factor:

- 1. If Friction Factor is positive, more buying than selling caused TMSH's price to rise
- 2. If Friction Factor is negative, more selling than buying caused TMSH's price to fall
- 3. If Friction Factor is 0, there was no discernable activity either way
- 4. If Friction Factor is abnormal, it means that there is either a bearish bias or a bullish bias to how market makers are making market in your stock.
